



# Resident Watercraft Permit and Oquirrh Lake Use Agreement 2018 Season

The following Resident Watercraft Permit and Oquirrh Lake Use Agreement is intended to inform our residents of the policies and procedures enforced at the lake. We want to make boating on the lake safe and enjoyable for all our residents and their guests.. **(Please read and initial):**

1. Lake area is open dawn to dusk.
2. Residents must be in good standing with the HOA in order to use a watercraft on the Oquirrh Lake.
3. No more than the designated maximum number of people shall occupy or use the watercraft at one time.
4. The following watercraft and sizes are permitted at the lake:
  - Row Boats (14' max length)
  - Canoes (17' max length)
  - Sea Kayaks (14' max length)
  - Sail Boats (14' max length, 18' max mast height) – no sailing north of island
  - Other watercraft as approved by the Association
  - Paddleboards are currently allowed upon passing a skill competency course at boat dock.
  - No motorized watercraft unless authorized by Daybreak Communities & Daybreak Community Association**
5. No recreational floatation devices.
6. **Resident must be present in the watercraft at all times.**
7. There is no storage available for resident watercraft on the lake or storage sheds.
8. No Alcohol / No Smoking.
9. No pets allowed in the watercraft.
10. Boaters must exit the lake immediately when the alarm sounds for inclement weather.
11. The watercraft shall be used in a safe and careful manner. All users of the watercraft shall comply with all state or local laws, Daybreak Community Association and Oquirrh Lake Boating rules and posted signs. A copy of the Daybreak and Oquirrh Lake Boating Rules are available for review upon request. Daybreak Community Association shall have no liability for failure to enforce state or local laws, Association rules or posted signs.
12. Users of the lake participate in water-related activities with knowledge of, and accept all risks associated with these activities. Users shall indemnify and hold Daybreak Community Association, CCMC, LiveDaybreak, Daybreak Properties and their directors and employees harmless from all claims or damages of any nature (including property damage and injury to or death of persons) arising from any violation of this Agreement, any negligence by any user of the watercraft or any other event, injury or casualty not caused by Daybreak Community Association's gross negligence.
13. Watercraft must be launched from designated approved locations only.
14. Inappropriate behavior will not be tolerated.
15. Residents must be 14 or older to captain a watercraft. Children under the age of 14 may only use the watercraft when a parent/guardian 18 years or older accompanies the child in the watercraft.
16. **Resident captain must have Daybreak ID in his/her possession at all times.**
17. Children under the age of 2 are not allowed on any watercraft.
18. The signer below agrees that all users of this watercraft will properly wear an appropriate lifejacket at all times.
19. Fishing is **NOT** permitted from watercraft.
20. Only HOA-approved watercraft is permitted on the lake. An official Daybreak permit must be placed on the front, port side of the watercraft.
21. Boat Permits are valid from April 2 – October 31.

**22. Any violation of these rules may result in immediate removal from the lake and loss of all amenity privileges for the remainder of the calendar year. Permittee understands that use of the lake may be limited or revoked at any time without notice.**

By initialing to the left, I understand and give permission to CCMC to apply a one time \$10.00 fee to my account. (This option is only available to Daybreak Homeowners on Sunday's after 2:00PM.
