

**DAYBREAK COMMUNITY ASSOCIATION
WATERCRAFT USE AGREEMENT
2017 SEASON**

The undersigned user agrees to use the watercraft described below from Daybreak Community Association on the following terms **(Please read and initial)**:

1. User agrees to pay for any damage to the watercraft caused by the User
2. No more than the maximum number of people shall occupy or use the watercraft at one time # _____
3. Resident Captain (14 or older) may fill the watercraft with either residents or guests, but he/she **MUST** be in the watercraft as captain. There is a \$5 Daybreak amenity guest fee per person to ride in a watercraft captained by a resident
4. The watercraft shall be used in a safe and careful manner. All users of the watercraft shall comply with all state or local laws, Daybreak Community Association and Oquirrh Lake Boating rules, and posted signs. A copy of the Daybreak and Oquirrh Lake Boating Rules are available for review upon request. Daybreak Community Association shall have no liability for failure to enforce state or local laws, Association rules, or posted signs
5. Users of the lake participate in water-related activities with knowledge of, and accept all risks associated with these activities. Users shall indemnify and hold Daybreak Community Association, CCMC, Livedaybreak, Daybreak Properties and their directors and employees harmless from all claims or damages of any nature (including property damage and injury to or death of persons) arising from any violation of this Agreement, any negligence by any user of the watercraft or any other event, injury or casualty not caused by Daybreak Community Association's gross negligence.
6. Daybreak Community Association does not provide accident insurance for its members or other users of the watercraft. All expenses related to the treatment of injuries incurred while using the watercraft will be the sole responsibility of the user or his/her insurance carrier
7. Residents must be 14 or older to captain a watercraft. Children under the age of 14 may only use the watercraft when a parent/guardian 18 years or older accompanies the child in the watercraft and signs this Agreement on the date of use
8. Children under the age of 2 are not allowed on any watercraft
9. The signer below agrees that all users of this watercraft will properly wear an appropriate lifejacket at all times
10. Fishing is NOT permitted from watercraft
11. **No changing passengers at any location other than this loading station**
12. Inappropriate behavior will NOT be tolerated
13. **Any violation of these rules may result in immediate removal from the lake and loss of all amenity privileges for the remainder of the calendar year.**
