# 2018 Bollywood at Daybreak Regulations and Conditions

*Please read the following and sign, acknowledging your agreement.*

The Daybreak Community Council is very pleased that you are interested in participating in the 2018 Bollywood at Daybreak. The purpose of this event is to allow Daybreak homeowners and local residents to experience the Indian culture in a fully immersive manner with entertainment, food, art and other related activities. These regulations and conditions are designed to make this event enjoyable for event participants and create structure for vendors. Your signature on the bottom of this form verifies you have read these regulations and conditions and agree to abide by them.

## **Regulations and Conditions for Participation:**

- Vendor businesses must be licensed by the State of Utah and must provide proof of licensure to the Council with a completed 2018 Bollywood at Daybreak Vendor Application. Licenses must be present at each individual booth.
- Vendor businesses that are also a Daybreak home business must submit proof of approval by the Daybreak Community Association ("**Association**"), or must apply for approved "Daybreak Home Business" status. Applications for a Daybreak home business may be made at the same time as the vendor application is submitted. Please call the **Daybreak Community Association** at 801-254-8062, for more details regarding the Daybreak home business application process.
- Vendor business agrees to pay respective fees for its participation in this event, payment of which shall be made by check to "DCC". Once the Vendor business is approved for participation, this fee becomes non-refundable under every circumstance.
- Acceptance of the vendor application by the LiveDAYBREAK Community Council ("**Council**") does not in any way mean an endorsement of the Vendor's services or products by Daybreak. Vendor business agrees that it will not advertise its business using the "Daybreak" name in any way.
- Vendor business may not sublet, assign or apportion any portion of its assigned space.
- Vendor business may not exceed its assigned space dimensions in any manner. Vendors are welcome to secure more than one space.
- No Vendor business may advertise or distribute materials outside of the space dimensions assigned to them or interfere with traffic in or around the exhibit area.
- LiveDAYBREAK Community Council ("**Council**") reserves the right to restrict and/or have removed any Vendor business at its discretion for any reason including, but not limited to: unprofessional behavior, solicitation beyond the assigned space, noise, objectionable method of operation, or any other reason that the Council may deem to violate the terms of these Regulations. In the event of such removal, restriction of exhibit or discontinuation of set up, the Association will not issue any refund for participation fees paid or expenses or damages incurred as the result of said removal.
- The Council may in its sole discretion remove or withdraw its permission to advertise or distribute any material it considers objectionable.

- Vendor businesses must supply their own display materials.
- No refunds will be issued.
- All food vendors must adhere to all Salt Lake County and South Jordan City health code policies. (See <http://slco.org/health/food-protection/temporary-food-events/> for necessary permits and information.)
- Vendor space decorations and exhibits shall conform to any and all fire regulations. Combustible or other flammable materials may not be used. All materials used by Vendor business must be flame proof. Toxic materials may not be used.
- Vendors must clean up the entirety of their designated event space including removing all decorations, products and trash.
- These regulations and Conditions become a part of the agreement between the Vendor business and the Council which includes this form and the “2018 Bollywood at Daybreak Vendor Application”. All matters in question not covered by these Regulations and Conditions are subject to the decision of the Council and all decisions made shall be so binding on all parties affected by them, as in the case of these original Regulations and Conditions. Authority to enforce these Regulations and Conditions is given to the LiveDAYBREAK Community Council Director.
